Inmarsat Approves Prototype Delivery Milestone For Beam Docking Station Development

Beam Communications, a wholly owned subsidiary of World Reach Limited, today announced that it has received sign off of the third milestone under the agreement entered into with Inmarsat plc (LSE:ISAT), under which Beam was appointed as the developer, manufacturer and distributor of docking units for IsatPhone Pro, Inmarsat's global handheld satellite phone planned for launch in June 2010.

The delivery of the prototype units has been achieved on schedule and the development of the four docking solutions for the IsatPhone Pro and is still on schedule to commence commercial delivery in Q3 2010.

The docking units that Beam is designing will broaden the appeal of IsatPhone Pro to different markets, and extend its use to a wider range of environments and applications. The docking stations will be branded as 'IsatDock by Beam'.

As previously announced, Inmarsat will provide Beam with a loan of up to US\$3.18M to fund product development and initial working capital costs. This loan is to be repaid in installments equal to an agreed percentage of sales of these products by Beam or the supply of products directly to Inmarsat. Due to the successful completion of the first three milestones loan funds can now be drawn down to US\$1.7M.

Sales of the Inmarsat docking units are expected to commence later this September quarter and are anticipated to exceed US\$7M over the initial two-year period.
